Fighting Climate Change Outside the Paris Accord

"In the months since President Trump declared that the United States would withdraw from the Paris climate deal, 14 state governors have vowed to continue upholding the agreement and press ahead with policies to fight global warming."

"Three governors in the United States Climate Alliance....unveiled a new study by the research firm Rhodium Group that said the 14 alliance states were on pace to meet their share of the Obama administration's pledge under the Paris accord, thanks in part to local mandates on renewable energy and electric vehicles. However, because the states in the alliance only represent 36 percent of the nation's population, the United States as a whole is still expected to fall short of Mr. Obama's pledge. A previous Rhodium Group analysis estimated that total United States emissions would likely drop just 15 to 19 percent by 2025 as Mr. Trump dismantled federal climate policies."

The ultimate significance of these state efforts, Dr. Victor said, may be to help prevent international climate efforts from collapsing, by reassuring other countries that the United States has not totally abandoned the issue.

Using the EPA to Prop Up Big Coal By The Editorial Board



"Eight months in, the [Trump] administration has already killed, or is in the process of killing, rules that would prevent the dumping of coal mining wastes in streams, impose a temporary moratorium on new mine leases in the West, and reduce greenhouse gas emissions from coal-fired power plants — one of President Barack Obama's most important efforts to resist climate change." Scott Pruitt, the administrator of the Environmental Protection Agency, ordered a two-year postponement of the Obama administration's tighter controls on lead, mercury, arsenic and other coal plant wastes that threaten human health. "In 2017 and 2018, at least 46 coal-fired units will close at 25 electricity plants in 16 states, according to the Institute for Energy Economics and Financial Analysis." In its outlook for 2017, the institute skewered Mr. Trump's campaign vows, saying, "Promises to create more coal jobs will not be kept — indeed the industry will continue to cut payrolls."
